1 **WHEREAS**, pursuant to the provisions of the Human Services Article of the Annotated Code of
2 Maryland, Section 3-501, each local Department of Social Services shall have a local board consisting of at
3 least nine (9), but no more than thirteen (13) members who have a high degree of interest, capacity, and
4 objectivity; and in the aggregate, give a countywide representative character to the local board, and

5 **WHEREAS**, Title 3, Subtitle 5, Section 3-503 of the Annotated Code of Maryland defines the duties
6 and functions of a local Social Services Board as an advisory board to the local director for the local
7 application and implementation of State policies or procedures, which includes evaluating and making
8 recommendations to improve current services and develop new services as needed in the county; and
9 serving as the liaison with the local government authority and residents to communicate the objectives,
10 policies and programs of local social services and public assistance administration; and

11 **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
12 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
13 and

14 **WHEREAS**, the County Executive has appointed David Rudolph to serve on the Department of
15 Social Services Board to complete Raymond Hamm’s term; and

16 **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**
17 **MARYLAND** confirms the appointment by the County Executive of David Rudolph to serve on the
18 Department of Social Services Board to a term that will expire on June 30, 2020; and

19 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by
20 the County Council of Cecil County, Maryland.
