Master Water and Sewer Plan – Map – Water Service Districts – Foundation for Eldercare

1 **WHEREAS**, the Environment Article of the Annotated Code of Maryland requires that the County
2 have a Master Water and Sewer Plan and provides for the administration, enforcement, and amendment of
3 Plan; and

4 **WHEREAS**, an amendment has been proposed to the Master Water & Sewer Plan, to amend the map
5 of Artesian Elkton West (Ceco, Highlands, Meadowview, Route 7 etc. and seven private systems) and the
6 map of North East, Artesian and two private systems, in order to indicate W-2 water service will be provided
7 by Artesian Water Maryland, Inc.; and

8 **WHEREAS**, the tax parcel 25-24-0462 was identified in a competitive franchise area whereby
9 individuals can seek service from Artesian or the Town of North East; and

10 **WHEREAS**, Artesian Water Maryland, Inc. was selected by Foundation for Eldercare as their service
11 provider; and

12 **WHEREAS**, Artesian Water Maryland, Inc. entered into a water service agreement with the
13 Foundation for Eldercare, located on tax parcel 25-24-0462 on the west side of Marley Road, shown on Map
14 25, as Parcel 462, Marley Road, Elkton, MD; and

15 **WHEREAS**, Artesian Water Maryland, Inc. has committed to provide water service for the proposed
16 228 townhouse project, and has allocated 15,260 gallons per day for this project; and

17 **WHEREAS**, Artesian Water Maryland, Inc. requested on February 7, 2018, that the Master Water and
18 Sewer Plan, water service district maps should be updated to reflect that tax parcel 25-24-0462 inclusion in
19 Artesian’s Elkton West territory, and no longer identified as “to be determined” as indicated in Exhibit A; and

20 **WHEREAS**, the Planning Commission held a public hearing on the proposed changes to the map on
21 March 19, 2018 and recommended approval, with the map being consistent with the 2011 Comprehensive
22 Plan.

23 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
24 **MARYLAND**, that the map amendment to the Master Water and Sewer Plan, Water Service Districts, for
25 Artesian Elkton West (Ceco, Highlands, Meadowview, Route 7 etc. and seven private systems) and North
26 East, Artesian and two private systems, as indicated by Appendix 1, 2 and 3 for Parcel 462 on Map 25,
27 Marley Road, Elkton, MD., is hereby adopted.

28 **BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that this map
29 amendment shall be submitted to the Maryland Department of the Environment for its approval, pursuant
30 to section 9-507 of the Environment Article of the Annotated Code of Maryland.
