Resolution No.24-2018 Budget Amendment – Grants –State's Attorney's Office – Town of Rising Sun WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2017, the 1 County Executive submitted a proposed budget to the County Council for Fiscal Year 2018; and 2 3 WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held 4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2018; and WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 15, 2017, the 5 Budget for Cecil County was adopted for Fiscal Year 2018; and 6 7 WHEREAS, the County Executive is revising the Fiscal Year 2018 Special Revenue – Other Grants Fund revenue estimate for Cecil County to establish the following amount: 8 a.) The addition of \$18,628 in revenue and expenditure to the Special Revenue – Other Grants 9 Fund operating budget to allow use of an asset forfeiture from the Town of Rising Sun, 10 Maryland that was shared with the Cecil County States Attorney's Office. 11 WHEREAS, such appropriation is necessary to provide \$18,628 of funding to allow the States 12 Attorney's Office to purchase new equipment, both hardware and software, and the related physical 13 items such as storage, electrical and microphones, which is compatible with both law enforcement digital 14 evidence technology; and the technology upgrades that were recently completed at the Cecil County 15 Courthouse. The ability to utilize the new technology within law enforcement and the courtrooms is vital 16 to the attorney and the case at hand is being heard at the Circuit Court. 17 18 NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal 19 Year 2018 is hereby amended for the supplemental appropriation and by amending the Current Budget to 20 appropriate additional expenditures in the Other Grants Fund – Special Revenue - States Attorney's Office 21 to record the amount of \$18,628 awarded by the Town of Rising Sun, Maryland. 22 AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that 23 this Resolution shall take effect on the date of its passage by the County Council of Cecil County, 24
