WHEREAS, Section 505 of the Charter of Cecil County requires the Executive to prepare a Proposed Capital Improvement Program as part of the Budget Message to County Council for the ensuing fiscal year not later than April 1 of each year; and

WHEREAS, the County Executive was not required to submit the Capital Improvement Program to the Planning Commission for Fiscal Years 2019-2023 because the Capital Improvement Program contains no new projects for FY 2019–2023; and

WHEREAS, all projects contained in the Capital Improvement Program for Fiscal Years 2019–2023 were recommended by the Planning Commission as part of the Capital Improvement Program for Fiscal Years 2018-2022; and

WHEREAS, on March 30, 2018 the County Executive submitted the proposed capital Improvement Program for Fiscal Years 2019–2023 to the County Council indicating the plan of the County to receive and expend funds for capital projects, and providing for each capital project, the project description, estimated costs and probable sources of funding; and

WHEREAS, the Cecil County Council has met all the requirements to consider the Capital Improvement Program for Fiscal Years 2019–2023.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,

MARYLAND that the Capital Improvement Program for the fiscal years ending June 30, 2019,

June 30, 2020, June 30, 2021, June 30, 2022, and June 30, 2023, attached as Appendix 1, is approved and adopted.

BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that that this Bill shall take effect July 1, 2018.
