2	Policies and Procedures Manual) [Amended 11-13-2012 by Ord. No. 2012-12], the County Council
3	adopted those provisions contained in the current revision of the Cecil County, Maryland, Personnel
4	Policies and Procedures Manual as the personnel policies and procedures that apply to Cecil County
5	employees, when relevant; and
6	WHEREAS, pursuant to Cecil County Code Chapter A384, § A384-2 (Change or Repeal of
7	Provisions; No Express or Implied Contract of Employment), the County Council reserves the right to
8	change or repeal any or all of the provisions of said Cecil County, Maryland, Personnel Policies and
9	Procedures Manual at any time; and
10	WHEREAS, the County Executive has determined that it is in the best interest of Cecil County to
11	repeal the existing Cecil County, Maryland Personnel Policies and Procedures Manual, and to replace the
12	repealed regulations by enacting a new Personnel Policies and Procedures Manual, in order to comply
13	with changes in applicable laws, to respond to certain changes to employee benefits and expectations
14	for employment, and to further the County Executive's commitment to the citizens of Cecil County by
15	instilling the following values as guiding principles for all interactions with each other and with County
16	citizens: teamwork, flexibility, accountability, mutual respect, excellence, and open and effective
17	communication; and
18	WHEREAS, the new Cecil County, Maryland Personnel Policies and Procedures Manual presented
19	for adoption by the County Council is attached as Appendix 1 hereto and incorporated by reference as
20	more fully set forth herein.
21	NOW, THEREFORE, BE IT ENACTED THAT THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,
22	finds that the proposed amendment to the Cecil County, Maryland Personnel Policies and Procedures
23	Manual is in the best interest of Cecil County, Maryland.
24	AND IT IS FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the
25	existing Cecil County, Maryland Personnel Policies and Procedures Manual is hereby repealed.
26	AND IT IS FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the
27	Cecil County, Maryland Personnel Policies and Procedures Manual as appended hereto and incorporated
28	by reference herein, as Appendix 1, is hereby adopted.

AND BE IT FURTHER ENACTED that this Act shall take effect on July 1, 2018.
