WHEREAS, it is also the policy of the State to authorize the power and authority to limit economic competition by regulating the sale of alcoholic beverages in order to obtain respect and obedience to law, to foster and promote temperance, to prevent deceptive business practices, and to promote the general welfare of its citizens by controlling the sale and distribution of alcoholic beverages; and

WHEREAS, the State authorizes the Board of License Commissioners of each county and Baltimore City by regulation to limit and restrict, in accordance with a definite standard, the number of licenses which they consider sufficient for any neighborhood, pursuant to Section 9-201, Title 9, Article 2B of the Annotated Code of Maryland; and

WHEREAS, the Cecil County Board of License Commissioners shall issue all retail alcoholic beverage licenses authorized under the State Alcoholic Beverage Article 2B, pursuant to Section 15-12(i); and

WHEREAS, the Cecil County Board of License Commissioners may employ inspectors to investigate applicants or transfers of alcoholic beverage licenses, enforce all alcoholic beverage laws, and investigate all violations and report them to the Board, pursuant to Section 15-122(i); and

WHEREAS, the Cecil County Board of License Commissioners is comprised of three members who are to be of high moral character, possess sound reputations of integrity, pursuant to Section 15-104(a-1) of the Annotated Code of Maryland; and

WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; and

WHEREAS, the County Executive has reappointed W. Edwin Cole, Jr. to serve on the Board of License Commissioners to a four-year term, which will expire on June 30, 2021.

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, confirms the reappointment by the County Executive of W. Edwin Cole, Jr. to serve on the Board of License Commissioners, to a four-year term, which will expire on June 30, 2021.

## AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that all
