Chairman Snelling called for a motion; Commissioner Cole made a motion to grant a 30-day trial period and at the end of that trial period he is to call Chief Bradford to verify there have been no complaints; Commissioner Miller seconded that motion and the Board unanimously granted the 30-day trial period with the conditions set forth by Commissioner Cole.
