| 4 | WHEREAS, the Town of Perryville is initiating the annexation at the request of the property owner, |
| 5 | Principio Iron Company L.P.; and |
| 6 | WHEREAS, the Mayor and Council of the Town of Perryville will meet on September 4, 2018 to |
| 7 | conduct a public hearing on Resolutions 2018-08 and 2018-09, resolutions to annex a parcel of land located |
| 8 | north of I-95, and bounded to the north by the Hollywood Casino Perryville property, by the BGE right of |
| 9 | way to the west, and the MD Transportation Authority's property and I-95 to the south, more commonly |
| 10 | known as the Principio Iron Company LP Property, and shown as Parcel 0733 on Tax Map 29, block 15; and |
| 11 | WHEREAS, the Annexation Resolution and supporting documents state that the zoning of the |

| 23 | Residential (ST) to the Town of Perryville's C-2 Highway Commercial zoning district. |
