# COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2018-13 July 17, 2018

The County Council of Cecil County met in legislative session at the County Administration Building, 200 Chesapeake Blvd., Elk Room, Elkton, MD. The following members of the Council were present:

#### **CALL TO ORDER**

The meeting of the County Council of Cecil County of July 17, 2018 was called to order by Council President Bowlsbey at 7:00 p.m. and opened with the Pledge of Allegiance.

#### **OPENING PRAYER**

Vice President Schneckenburger introduced Rev. Karen Bunnell from Elkton United Methodist Church who lead the opening prayer.

#### **APPROVAL OF AGENDA**

On motion made by Councilwoman Gregory, seconded by Councilman Meffley, moved to approve the legislative agenda of July 17, 2018. Motion was carried unanimously.

### PRESENTATIONS OF PROCLAMATIONS/CERTIFICATES

The 2017 MRA Recycling Awards were presented by Cliff Engle, Solid Waste Management Chief, and Tanya Adams, Recycling Program Manager. Certificates of recognition were presented to Junkbeegone.com, Waste Management, Waste Master Solutions, Elkton Recyclers, Inc., W.L. Gore, Town of Chesapeake City, Stonegate Apartments, and Elkton United Methodist Church. Frank Vari, Chesapeake City Town Commissioner, joined Ms. Adams in recognizing David Brookens, Jr., former owner of Junkbeegone, for his long commitment to the Cecil County community. Mr. Brookens family were also recognized for their loss.

Commissioner Vari also presented an honorary Town of Chesapeake City patch to Council President Bowlsbey and Vice President Schneckenburger to thank them for their service on the Cecil County Council and in the community.

# **APPROVAL OF MINUTES**

#### PRESIDENT AND COUNCIL COMMENTS

Councilman Patchell attended the Parks and Recreation and commented on the newly formed Friends of Cecil County Parks and Recreation.

Councilman Meffley attended the Farm Bureau meeting and commented on the pollution on Lake Erie and the lack of nutrient plans and pollution programs in the state of Ohio. He also commented on the Farm Bureau's need for a permanent building at the Cecil County Fair and his plan to ask the Vo-Tec school to allow students to construct this building, with materials supplied by the Farm Bureau.

Councilwoman Gregory attended the Women's Republican Club of Cecil County and commented about the attending the Cecil County Fair.

Vice President Schneckenburger thanked the audience for attending tonight's session. He commented that he serves as an ex-officio member to the Cecil County Fireman's Association and stated that they are still working to resolve a fire equipment funding issue with the administration. He also commented on the large number of public hearings to be held at the beginning of this fiscal year.

Council President Bowlsbey attended the Correctional Officers graduation and commented on the seven new correctional officers that have been trained in-house instead of taking training out of the county.

Resolution No. 28-2018: Fees – Wastewater Rates

A Resolution to increase the rates of the Cecil County Wastewater system.

Al Wein, Director of Administration, provided introductory comments. Lisa Saxton, Finance Director, presented a Powerpoint on the wastewater rate study, which included an overview of the current system and the reasons for the proposed rate increase. The administration's proposal includes increases in metered and non-metered rates for the next three fiscal years, establishing a two-tiered rate for high volume users over 100,000 gallons, and lowering the minimum metered rate to 9,000 gallons instead of 10,000 gallons.

#### **Cecil County Public Schools – Budget Amendment #52**

Councilwoman Gregory made a motion to approve Cecil County Public Schools Budget Amendment #52, which was seconded by Councilman Meffley. This budget amendment authorizes budget changes in June 2018 in the amount of \$1,027,888.

Motion was approved by a voice vote of 5 to 0.
