WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the Budget for Cecil County was adopted for Fiscal Year 2019; and WHEREAS, the County Executive is revising the Fiscal Year 2019 revenue estimate for Cecil County to increase use of the Assigned Fund Balance for school security by \$1,000,000 to allow the following appropriation within the General Fund: a.) The addition of \$1,000,000 in expenditures for the Small Capital budget within the Board of Education Department's budget to protect Cecil County public school students. The safe school upgrade project scope will be submitted to the County Executive. The expenditures will be reimbursed by the County once justification is provided to the Director of Finance; and WHEREAS, such appropriation is necessary to provide \$1,000,000 of the County Executive's FY2018 assigned fund balance for the General Fund for expenditures. NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal Year 2019 is hereby amended for the supplemental appropriation and by amending the Current Budget to appropriate \$1,000,000 of additional expenditures in the General Fund to the Board of Education Department's budget. BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this Resolution shall take effect on the date of its passage by the County Council of Cecil County, Maryland.
