2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the
6	County Council adopted the budget for Fiscal Year 2019; and
7	WHEREAS, the State of Maryland through the Department of Housing and Community
8	Development has solicited applications from eligible jurisdictions to apply for funding under the
9	Maryland Community Development Block Grant Program; and
10	WHEREAS, Cecil County is eligible to apply for funds from the Maryland Community
11	Development Block Grant program through the Maryland Department of Housing and Community
12	Development; and
13	WHEREAS, the Department of Community Services, representing Cecil County, has been
14	authorized to apply for up to \$508,000 in grant funds received from loan repayments and interest
15	capitalized by Community Development Block Grant funding designated for economic development
16	projects in Cecil County; and
17	WHEREAS, the Department of Community Services, through its Housing and Community
18	Development Division and in collaboration with the Cecil County Department of Economic
19	Development, has identified Warwick Mushrooms as an eligible recipient of said grant funds; and
20	WHEREAS, Warwick Mushrooms has agreed to use County grant funds to acquire equipmen
21	that is required for an expansion of its operations in Warwick, Cecil County, Maryland, with such
22	expansion to add approximately 28 full time equivalent jobs within 24 months; and
23	WHEREAS, the County has held the required public hearing related to the formulation of the
24	County's Block Grant Application; and
25	WHEREAS, the County Council understands and acknowledges that the County would be
26	responsible for completion of grant activities and any corrective actions including the repayment of

Grant Application-Maryland Community Development Block Grant-Warwick Mushrooms

Project Information

Community Development Block Grant Funding (CDBG):

- The anticipated State of Maryland Community Development Block Grant allocation for SFY 2019 is approximately \$7,114,498;
- Cecil County has been authorized to apply for up \$508,000 in grant funds received from loan repayments and interest capitalized by Community Development Block Grant funding designated for economic development projects in Cecil County.

Eligible Activities that **may** be undertaken with CDBG funds through the normal application process:

- Acquisition of real property; acquisition, construction, reconstruction, or installation of public works facilities;
- Code enforcement in deteriorating areas;
- Clearance, demolition, removal, reconstruction and rehabilitation of buildings and improvements;
- Removal of materials which restrict mobility and accessibility of elderly or handicapped persons;
- Provision of a new or quantifiable increase in a public service;
- Payment of the non-federal share required in connection with a federal grant-in-aid program undertaken as part of the program;
- Relocation payments for displaced individuals, families, businesses, organizations and farm operations;
- Planning;
- Payment of administrative costs;
- Assistance including loans and grants for activities carried out by public or private nonprofit entities;
- Assistance to neighborhood-based nonprofit organizations, local development corporations, and nonprofit organizations serving the development needs of the Small Business Investment Act of 1958, to carry out a neighborhood revitalization or community economic development or energy conservation project;
- Activities necessary to the development of energy use strategies related to the recipient's development goals;
- Provision of assistance to private for-profit entities, when the assistance is appropriate to carry out an economic development (ED) project;

- Rehabilitation or development of housing assisted under former Section 17 of the United States Housing Act of 1937;
- Housing services such as housing counseling, energy auditing, preparation of work specifications, loan processing, inspections, tenant selection, management of tenant based rental assistance;
- Direct assistance to facilitate and expand homeownership among LMI persons.

Cecil County is authorized to utilize grant funds designated for economic development projects in Cecil County.

Proposed Project:

- Cecil County has identified Warwick Mushrooms as an eligible recipient of grant funds to acquire equipment required for an expansion of its operations;
- The expansion will add an additional 80,000 square feet of growing surface, spread amongst sixteen growing rooms, incrementally producing an additional 80,000 pounds of mushrooms and creating approximately 28 new, full-time equivalent jobs within 24 months.
