- Smart to tap into Philadelphia market
- In October, Matt Cabrey from Select Greater Philadelphia Council will be presenting to EDC.
- What is advantage to bring us (Cecil) in to Greater Philadelphia area?
  - Philadelphia is 4X larger than Baltimore market
  - Cecil has open space
- Delaware we have better relationships in Delaware; they know who we are and what we are
- State of Delaware is a member of Select Greater Philadelphia Council
- Branding Study final presentation 3<sup>rd</sup> week of September, Elkton and Cecil County back-to-back meetings.
- Need to change perception of bickering
  - Change mindset for growth in corridor
- How do Cecil County incentives compare with other counties in Maryland?
  - They are very comparable.
  - More growth areas in our Enterprise Zones
  - Easier permit process
  - Opportunity Zone (Federal program)
  - Opportunities in Principio coming in next few years; need to leverage and Bainbridge
- Cecil in strong position compared to others because we have the land; everywhere else is built out
