Synopsis: A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2019 in order to provide a total of \$639,720 over three years to the Community Services Fund – Department of Community Services to record the grant award from the Department of Justice, Office for Victims of Crime for the purpose of enhancing community responses to the opioid crisis by serving our youngest crime victims.

Supplemental Appropriation – Grant – Community Services Department

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the
6 Budget for Cecil County was adopted for Fiscal Year 2019; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2019 Community Services Fund revenue
8 estimate for Cecil County to establish the following amount:

- 9 a.) The addition of \$639,720 over three years in grant revenue and expense to the Community
10 Services Fund – Department of Community Services budget to provide for the Department of
11 Justice, Office for Victims of Crime Grant award to Cecil County.

12 **WHEREAS**, such appropriation is necessary to provide \$639,720 over three years of grant funding
13 for the County to leverage close relationships with a wide variety of community partners in order to
14 continually collect and assess indicator data, provide direct services to impacted youth, convene
15 community forums to inform and train professionals and to promote community awareness, conduct
16 monthly briefings for program partners and share all available resources to meet the needs of this
17 population; the funds will be used to contract with trauma-trained therapists to work with clients
18 referred by the community partners.

19 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
20 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
21 Year 2019 is hereby amended for the supplemental appropriation and by amending the Current Budget to
22 appropriate additional expenditures in the Community Services Fund – Department of Community
23 Services, to record the grant award in the amount of \$639,720 over three years from the Department of
24 Justice, Office for Victims of Crime to Cecil County for the purpose of enhancing community responses to
25 the opioid crisis by serving our youngest crime victims.

26 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
27 this Resolution will become effective upon its passage.
