COUNTY COUNCIL OF CECIL COUNTY WORK SESSION MINUTES October 16, 2018

9:00 A.M. —Council President Bowlsbey called the meeting to order at 9:00 a.m. and determined a quorum.

Approval of Minutes

On a motion made by Councilwoman Gregory, seconded by Councilman Meffley, the Council moved to approve the minutes of the Council work session of October 9, 2018, as presented. Motion was approved unanimously.

Chesapeake City Ecumenical Association

Eileen Viars, President of the Chesapeake City Ecumenical Association, provided an overview of her nonprofit agency that serves Chesapeake City and the surrounding communities. She provided a history of the organization and the partnerships established with churches and agencies that help families and children. She described their programs that includes food pantry, clothing and household support, community wellness and emergency funding. Rev. Jack Shitama, a volunteer from Generation Station, explained the program that serves youths in grades six to nine. This program offers a safe place for children after school with homework assistance and programs to support their positive development. He stated that transportation from school to their center and then to home is an essential component of this program. Ms. Viars also stated that CCEA is very interested in finding a new facility and would like to move to the existing Chesapeake City Elementary School after a new school is built. Council questions and comments ensued. Council President Bowlsbey suggested that her organization contact the County Executive about their interest in the school building.

Review of Legislative Agenda

Resolution No. 40-2018 Supplementary Appropriation – Grant – Community Services Department, will be considered for approval at tonight's session. Al Wein, Director of Administration, provided a summary of the legislation. There were no Council questions or comments.

Resolution No. 41-2018 Support – Tax Credit – Plumpton Park Zoo, introduced by Vice President Schneckenburger, discussed the legislation as a request for the delegation to consider amending state law. Al Wein, Director of Administration, stated that the administration opposed the legislation because the zoo was not the property owner. Jason Allison, County Attorney, also stated his opposition to this legislation because the property tax exemption goes to the property owner and that the zoo leases the property. Council Members discussed these issues and determined by

consensus that the legislation should be tabled until further clarification the legality of this proposal. Formal actions will be held at tonight's legislative session.

Bill No. 2018-16 Agricultural Preservation District – Losten's Dairy, LP, will be considered for final approval at tonight's session. There were no Council questions or comments.

Bill No. 2018-17 Agricultural Preservation District – Bare Family Farm, will be considered for final approval at tonight's session. There were no Council questions or comments.

Cecil County Public Schools' budget amendment #55 will be considered for approval at tonight's session. There were no Council questions or comments.
