**RESOLUTION NO. 44-2018**

**Title of Resolution:** Water and Sewer – Sewer Use – Connection Charge

**Synopsis:** A Resolution to re-establish a reduction of the connection fee for residential living units from \$12,000 per equivalent living unit to \$6,000 per equivalent living unit within the Cecil County Sanitary District; to establish that the \$6,000 reduction applies to all subdivisions receiving approval prior to July 31, 2020, and will remain in effect as long as the subdivision maintains its validity; and to re-establish that terms of any installment payment of the wastewater connection charge to be subject to terms as specified in the Sanitary District Policy.

Water and Sewer – Sewer Use – Connection Charge

1           **WHEREAS**, pursuant to Section 365-38 of the Code of Cecil County: “The County reserves  
2 the right to establish said rates and connection charges by a future sewer user regulation and to  
3 increase and decrease said rates and charges from time to time by further regulation and to  
4 establish different classifications as to rates for residential sewer systems, commercial and  
5 industrial use.”; and

6           **WHEREAS**, Cecil County Council Resolution 31-2017, adopted July 18, 2017, decreased the  
7 wastewater connection charge for each residential equivalent living unit from \$12,000 per  
8 equivalent living unit to \$6,000 per equivalent living unit, established that the installment payment  
9 method of residential wastewater connection charges would be published, and changed through  
10 the Sanitary District Policy issued by the Director of Sanitary Facilities (the Director of Public  
11 Works), and provided that decrease of the wastewater connection charge for each residential  
12 equivalent living unit from \$12,000 per equivalent living unit to \$6,000 per equivalent living unit  
13 was effective upon passage of Resolution 31-2017, and would sunset 24 months after the date of  
14 passage, with the option for the County Executive to extend the period of reduction for an  
15 additional 6 months for individuals who have a valid building permit at sunset; and

16           **WHEREAS**, the County Executive requests introduction and passage of this Resolution to  
17 extend the sunset date to July 31, 2020, to establish that the \$6,000 reduction applies to all  
18 subdivisions receiving approval prior to July 31, 2020 and will remain in effect as long as the  
19 subdivision maintains its validity, to re-establish that the wastewater connection charge for each  
20 residential equivalent living unit which shall, upon passage of this Resolution, remain \$6,000, and to  
21 re-establish that the installment payment method of residential wastewater connection charges is  
22 to be published in, and changed through, the Sanitary District Policy issued by the Director of  
23 Sanitary Facilities (the Director of Public Works).

24           **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
25 **MARYLAND**, that an extension of the sunset date for reduction of the wastewater connection  
26 charge for each residential equivalent living unit is in the best interest of Cecil County, Maryland.

27           **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**  
28 that the extension of the reduction of the wastewater connection charge for residential equivalent  
29 living units from \$12,000 per equivalent living unit to \$6,000 per equivalent living unit is hereby  
30 approved and adopted.

31           **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**  
32 that the decrease of the wastewater connection charge for each residential equivalent living unit  
33 from \$12,000 per equivalent living unit to \$6,000 per equivalent living unit will be effective upon  
34 passage of this Resolution, and will sunset on July 31, 2020. All subdivisions receiving approval  
35 prior to July 31, 2020 shall qualify for the \$6,000 per equivalent living unit charge as long as the  
36 project maintains its validity.

37           **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY MARYLAND,**  
38 that the installment payment method of residential wastewater connection charges will be  
39 published in, and changed through, the Sanitary District Policy issued by the Director of Sanitary  
40 Facilities (the Director of Public Works).

41           **AND, BE IT FURTHER RESOLVED THAT** this resolution shall take effect on the date of its  
42 passage by the County Council of Cecil County, Maryland.
