CALL TO ORDER

The meeting of the County Council of Cecil County of October 16, 2018 was called to order by Council President Bowlsbey at 7:00 p.m. and opened with the Pledge of Allegiance.

OPENING PRAYER

Council President Joyce Bowlsbey introduced Rev. James Yeakel from Immaculate Conception Parish, who led the opening prayer.

APPROVAL OF AGENDA

PUBLIC COMMENTS

Dee Emsley, Rising Sun, commented on black fly situation near Octoraro Creek and the county's efforts to mitigate the problem.

PRESIDENT AND COUNCIL COMMENTS

Councilman Patchell attended the Parks and Recreation Advisory Board and commented on the establishment of the Friends of Parks and Recreation. He also reported that playground equipment has been ordered for the new park at Bittersweet Golf Course. He also stated that Calvert Regional Park has six tournaments scheduled this weekend and ten tournaments in 2019.
