1           **WHEREAS**, pursuant to Section 8-301, Subtitle 3, Title 8 of the Human Services Article of the  
2 Annotated Code of Maryland, each county shall establish and maintain a local management board to  
3 ensure the implementation of a local interagency service delivery system for children, youth, and  
4 families, and

5           **WHEREAS**, pursuant to Section 8-302, a local management board may be composed of public  
6 and private community representatives who share the responsibility for implementing a community-  
7 based, interagency, family-focused service delivery system for children, youth, and families; and

8           **WHEREAS**, pursuant to Section 8-303, a local management board shall strengthen the  
9 decision-making capacity at the local level; design and implement strategies that achieve clearly  
10 defined results for children, youth, and families; maintain standards of accountability for locally  
11 agreed upon results; influence the allocation of resources across the system; build local partnerships  
12 to coordinate services; and create an effective system of services, supports, and opportunities that  
13 improve outcomes for all; and

14           **WHEREAS**, the Local Management Board in Cecil County is known as the Human Services  
15 Agency; and

16           **WHEREAS**, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County  
17 Executive shall appoint all members of boards and commissions, subject to confirmation by the  
18 Council; and

19           **WHEREAS**, the County Executive has appointed Jeffrey A. Lawson to the Human Services  
20 Agency for a two year term to expire on December 18, 2022.

21           **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
22 **MARYLAND**, that the appointment of Jeffrey A. Lawson to the Human Services Agency for a two  
23 year term is confirmed, term to expire on December 18, 2022.

24           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**  
25 that all provisions of this Resolution shall take effect on the date that the Resolution is adopted.
