Electrical Code – Compliance Requirements – Board of Electrical Examiners

1	WHEREAS, pursuant to Section 402 of the Cecil County Charter (the "Charter"), the County
2	Executive (the "Executive") shall see that the affairs of the executive branch are administered properly
3	and efficiently, and that employees of the executive branch faithfully perform their duties; and
4	WHEREAS, pursuant to Section 402 of the Charter, the duties and responsibilities of the Executive
5	include, but are not limited to: (a) Supervising and directing offices, agencies and divisions of the
6	executive branch and ensuring that County employees as well as County boards and commissions
7	faithfully perform their duties; and, (b) preparing and submitting to the Council the annual County
8	Budget; and
9	WHEREAS, pursuant to Chapter 191, of the Cecil County Code, there is an Electrical Standards
10	Ordinance; and
11	WHEREAS, the County has adopted the National Electric Code, codified as Cecil County Code,
12	Chapter 191, Electrical Standards, Article I (General Provisions), Section 191-3 (Compliance Required); and
13	WHEREAS, membership, terms, and vacancies related to the Cecil County Board of Electrical
14	Examiners have been codified as Cecil County Code, Chapter 191, Electrical Standards, Article II (Board of
15	Electrical Examiners), Section 191-6 (Membership; Terms, Vacancies); and,
16	WHEREAS, the Chief, Permits and Inspections Division, Cecil County Department of Land Use and
17	Development Services, together with the Cecil County Electrical Board, have recommended amendments,
18	insertions, and deletions to Chapter 191, Article I, Section 191-3 and Article II, Section 191-6, respectively,
19	of the Cecil County Code, as more fully set forth herein; and
20	WHEREAS, the County Executive has submitted the amendments set forth herein to the County
21	Council for consideration and approval.
22	NOW, THEREFORE, BE IT HEREBY ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY,
23	MARYLAND, that the National Electric Code adopted under Cecil County Code, Chapter 191, Electrical
24	Standards, Article I (General Provisions), Section 191-3 (Compliance Required), as wells as Cecil County
25	Code, Chapter 191, Electrical Standards, Article II (Board of Electrical Examiners), Section 191-6
26	(Membership; Terms, Vacancies), are amended as follows:
27	§ 191-3 Compliance required.
28	(Amended 11-13-2012 by Ord. No. 2012-12; 9-2-2014 by Bill No. 2014-21)

- 29 All electrical installations in Cecil County shall meet the standards and requirements set forth by the
- National Electrical Code as established in § 191-2 above. The following provisions replace and supersede
- parallel provisions of NFPA 70, 2014 **2017** of the NEC:
- A. Wireless low voltage systems. An electrical permit or electrical inspection is not required for wireless low voltage systems that:
 - (1) Are 50 volts or less;

- (2) Have approved third-party devices; and
- 36 (3) Do not include or require permanent wiring.
 - B. Ground bar for utilities (article 250, NEC). Ground bar for utilities shall have three termination points on grounding conductors or three split bolts.
 - **E. B.** Aluminum conductors. Aluminum conductors shall be No. 6 or larger.
- 40 **D. C.** Small appliance circuits.
- 41 (1) Two identified appliance branch circuits shall be installed in the kitchen to service 42 the countertop surfaces.
 - (2) The two identified appliance branch circuits installed in the kitchen to service countertop surfaces shall not supply any other receptacles.
 - (3) All other code instructions in the NEC pertaining to small appliance circuits shall be adhered to and equally divided among the countertop.
 - **E.D.** Illumination of interior and exterior stairways. All interior and exterior stairways shall be illuminated.
- 49 (1) Interior and exterior stairways shall have a luminaire installed at each landing of the stairway.
- 51 (2) Interior and exterior stairways shall have a switch or automatic activation device 52 installed at the top and bottom of each stairway without traversing any risers.
 - (3) Exterior stairways shall have a luminaire installed at the top of the stairway.
- 54 (4) Basement stairways shall have a luminaire installed at the bottom of the stairway.
- 55 **F.**E. Temporary services. Temporary services shall require the installation of one eight-foot ground rod.
- 57 **G.F.** Exception to NEC section ARTICLE 250.52(A)(3). NEC section 250.52(A)(3) shall not apply in dwelling units with concrete encased electrodes.
 - **H.G.** Color code. The following color codes shall apply:

- 60 (1) 480/277V: brown, orange, yellow (BOY);
- 61 (2) 240/120V: black, orange (or tagged high leg), blue (BOB); and
- 62 (3) 120/208V: black, red, blue (BRB).

- (1) No. 10 and smaller: Undergrounded conductors No. 10 and smaller must be identified for the complete length.
- (2) No. 8 and larger: Undergrounded conductors No. 8 and larger can be identified at each termination and junction box.
- **J.-H.** Vacuum systems. Vacuum systems that utilize electrical equipment or electrical devices that exceed 50 volts to ground or phase-to-phase shall be installed by a master electrician.
- I. GAS PIPING SYSTEMS. GAS PIPING SYSTEMS SHALL BE BONDED IN ACCORDANCE WITH SECTION 310 OF THE INTERNATIONAL FUEL GAS CODE (IFGC).
- 72 § 191-6 Membership; terms; vacancies.
 - A. In accordance with the Charter, the County Executive shall appoint a board which shall be known as the "Board of Electrical Examiners," consisting of seven persons for the purpose of examining the qualifications and capabilities of all persons who are engaged in, or desire to engage in, the business of master electrician or limited electrician as defined in this chapter.
- 77 (Amended 11-13-2012 by Ord. No. 2012-12)
 - B. The County Executive, in accordance with the Charter, shall appoint seven members. All members shall be residents of Cecil County, OR SHALL BE A LICENSED MASTER ELECTRICIAN IN CECIL COUNTY WITH PRINCIPAL PLACE OF BUSINESS OF THEIR COMPANY ESTABLISHED AND IN GOOD STANDING IN CECIL COUNTY. The Board so appointed shall consist of at least four persons, who are competent practical Cecil County master electricians who have been duly licensed as master electricians for at least three consecutive years prior to the appointment. One member shall be a person whose name appears on a list of candidates recommended by the Cecil County Fireman's Association, if such a list is furnished to the County Executive. The remaining member or members shall be persons selected by the County Executive, as may be deemed appropriate, who may or may not be from the building industry, a utility company or the general public.

- C. Two of the members appointed shall serve a term of one year, three of the members appointed shall serve terms of two years, and two of the members appointed shall serve terms of three years. All appointments for successors to the members appointed shall be for a period of three years.
- D. If a vacancy occurs for any cause during the term of a Board member as herein provided for, the County Executive shall appoint someone to fill the vacancy for the remainder of the term of said Board member. In the case of a vacancy from among the practical electrician Board members, the Board of Electrical Examiners shall submit to the County Executive a list of three names of potential replacements, and such appointment shall occur within 60 days.
- E. The Board of Electrical Examiners shall continue to serve at the pleasure of the County Executive and shall be designated with the duties as enumerated in § 191-10 of this chapter.
- AND BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that this Act shall take effect in 60 calendar days from the date it becomes law.
