# COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2018-20 December 4, 2018

## **CALL TO ORDER**

The meeting of the County Council of Cecil County of December 4, 2018 was called to order by Council President Meffley at 7:00 p.m. and opened with the Pledge of Allegiance.

# PRESIDENT AND COUNCIL COMMENTS

Councilman Patchell welcomed Councilman Coutz and Councilman Miller. He also congratulated Council President Meffley and Vice President Gregory.

She attended the Interagency on Homelessness and commented that they are proposing to combine with Harford County in order to be qualified for additional grant funds. She applauded the opening of Taco and Tequila in downtown North East.

Council President Meffley visited Bohemia Manor High School and middle school. He commented on the outstanding curriculum, which includes robotics. He attended the holiday reception held for Cecil and Harford officials at General Taylor's home at Aberdeen Proving Ground. ### **INTRODUCTION OF BILLS**

Council Manager Massey stated for the record:

Resolution No. 2018-18 Budget Transfer – Wastewater Capital Budget – Replace Port Deposit Wastewater Treatment Plant

A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fisca' year ending June 30, 2019 to transfer existing bond appropriation authority within the Wastewater Capi. Projects Budget in the amount of \$1,719,269.13 from completed Wastewater Capital Projects (Construct Principio Sanitary Sewer - North \$569,062.13, Replace CSX Sewer Line at Red Toad- \$40,000, I&I Meadowview, Cherry Hill, Highlands - \$50,000 & Upgrade NERAWWTP - \$1,060,207) to the Replace Port Deposit WWTP Project. The bill also removes existing bond authority of \$555,000 from two inactive projects, (Expand Meadowview WWTP -\$430,000 & Upgrade Two Port Deposit Pump Stations -\$125,000) and add it to the Replace Port Deposit WWTP Project. The bill adds additional bond authority of \$763,175 to the Wastewater Capital Budget to allow for sufficient funding for the Replace Port Deposit WWTP Project. The bill will remove \$2,500,000 in estimated State grant funding and \$2,500,000 of other funding from the project funding schedule to reflect the County's plan to build a locally funded package plant to serve the sewer needs of the Town of Port Deposit. The end result of the bill is County bond expenditure authority of \$8,737,444 to Replace Port Deposit WWTP.

Al Wein, Director of Administration, provided introductory comments. There were no Council questions or comments.

Introduced, read first time, and posted on December 4, 2018. The public hearing for Bill No. 2018-18 wibe advertised and scheduled on the Council legislative session of January 8, 2019.

A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2019, to add bond appropriation authority within the Facilities Management Capital Projects Budget in the amount of \$50,000 to complete the Courthouse Holding Cell Renovation Project.

Al Wein, Director of Administration, provided introductory comments. There were no Council questions or comments.

Introduced, read first time, and posted on December 4, 2018. The public hearing for Bill No. 2018-20 will be advertised and scheduled on the Council legislative session of January 8, 2019.

# Resolution No. 43-2018 Appointment—Cecil County Mental Health Core Service Agency Advisory Board – Tyra Kenly and Rebecca Smith

A Resolution to confirm the reappointment by the County Executive of Tyra Kenly and to confirm the appointment of Rebecca Smith to the Cecil County Mental Health Core Service Agency Advisory Board for three (3) year terms to expire December 18, 2021

Council Manager Massey stated for the record:

### Resolution No. 44-2018 Water and Sewer – Sewer Use – Connection Charge

A Resolution to re-establish a reduction of the connection fee for residential living units from \$12,000 per equivalent living unit to \$6,000 per equivalent living unit within the Cecil County Sanitary District; to establish that the \$6,000 reduction applies to all subdivisions receiving approval prior to July 31, 2020, and will remain in effect as long as the subdivision maintains its validity; and to re-establish that terms of any installment payment of the wastewater connection charge to be subject to terms as specified in the Sanitary District Policy.

Al Wein, Director of Administration, provided introductory comments.

Council questions and comments included clarification that this connection charge would apply to new residential living units as long as subdivisions receive approval prior to July 31, 2020 and that the project maintains its validity.

Introduced, read first time and order posted on December 4, 2018, and scheduled for consideration on December 18, 2018.

#### **NEW BUSINESS**

Cecil County Public Schools – Budget Amendment #56

Vice President Gregory made a motion, seconded by Councilman Coutz, to approve Cecil County Public Schools Budget Amendment #56 in the amount of \$1,111,816 for transactions during October 2018.

The motion was approved unanimously by a voice vote of 5 to 0.
