Appointment – Human Services Agency

WHEREAS, pursuant to Section 8-301, Subtitle 3, Title 8 of the Human Services Article of the 1 Annotated Code of Maryland, each county shall establish and maintain a local management board to 2 ensure the implementation of a local interagency service delivery system for children, youth, and 3 families, and 4 WHEREAS, pursuant to Section 8-302, a local management board may be composed of public 5 and private community representatives who share the responsibility for implementing a community-6 based, interagency, family-focused service delivery system for children, youth, and families; and 7 WHEREAS, pursuant to Section 8-303, a local management board shall strengthen the 8 decision-making capacity at the local level; design and implement strategies that achieve clearly 9 defined results for children, youth, and families; maintain standards of accountability for locally 10 agreed upon results; influence the allocation of resources across the system; build local partnerships 11 to coordinate services; and create an effective system of services, supports, and opportunities that 12 improve outcomes for all; and 13 WHEREAS, the Local Management Board in Cecil County is known as the Human Services 14 Agency; and 15 WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County 16 Executive shall appoint all members of boards and commissions, subject to confirmation by the 17 Council; and 18 WHEREAS, the County Executive has appointed Jeffrey A. Lawson to the Human Services 19 Agency for a two year term to expire on December 18, 2022. 20 NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, 21 MARYLAND, that the appointment of Jeffrey A.
