WHEREAS, Pursuant to Section 10-1201 of Subtitle Core Service Agencies, Title 10 Mental 1 Hygiene Law, in Article X Health- General of the Annotated Code of Maryland, the Core Service 2 Agency is the designated county authority that is responsible for planning, managing, and 3 monitoring publicly funded mental health services; and 4 WHEREAS, Pursuant to Section 10-1202(1) of Subtitle Core Service Agencies, Title 10 Mental 5 Hygiene Law, in Article X Health- General of the Annotated Code of Maryland, the Core Service 6 Agency is an agent of a county government which may include a local health department; and 7 WHEREAS, Pursuant to Section 10-1202(d)(2) of Subtitle Core Service Agencies, Title 10 8 Mental Hygiene Law, in Article X Health- General of the Annotated Code of Maryland, the Core 9 Service Agency must incorporate in its method of governance a mechanism for the local county 10 mental health advisory committee to serve as the advisory committee to the core service agency; 11 and 12 WHEREAS, the Cecil County Mental Health Core Service Agency Advisory Board was 13 established to assure the existence and access to mental health services for Cecil County; and 14 WHEREAS, Pursuant to Article 4, Section 412 (b) of the Charter of Cecil County, the County 15 Executive shall appoint all members of boards and commissions, subject to confirmation by the 16 17 Council; and WHEREAS, the County Executive has re-appointed Tyra Kenly to a three year term to expire 18 on December 18, 2021 and appointed Rebecca Smith to a three year term to expire on December 19 20 18, 2021. NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, 21 MARYLAND, that the reappointment of Tyra Kenly and the appointment of Rebecca Smith to serve 22 on the Cecil County Mental Health Core Service Agency Advisory Board for a 3 year term to expire 23 December 18, 2021, is hereby confirmed. 24 INTRODUCED: December 4, 2018 ADOPTED: December 18, 2018 President of the Council
