2 government, health, safety, and welfare in the County; and

3 **WHEREAS**, a goal in the Cecil County’s Strategic Plan is to create an environment that encourages
4 economic growth through job creation, business development, and community revitalization; and

5 **WHEREAS**, Clene Nanomedicine, located in the Principio Business Park in North East, Maryland, has
6 applied for grant funding from the Maryland Department of Housing and Community Development’s
7 Neighborhood Business Works Program in order to expand their operations and create jobs; and

8 **WHEREAS**, this project is located in a State-approved locally-designated Enterprise Zone and an
9 Opportunity Zone, and conforms to the local zoning code; and

10 **WHEREAS**, the regulations of the Neighborhood Business Works Program require that all projects
11 that receive financing be approved and supported by the appropriate governing body of the locality in
12 which the project is located.

14 **MARYLAND**, that the application of Clene Nanomedicine for funding from the Neighborhood Business Works
15 Program with the Maryland Department of Housing and Community Development, has the full support of the
16 County Council.

18 Business Works Program at Maryland Department of Housing and Community Development.
