Supplemental Appropriation – Facilities Management Capital Budget – Courthouse Holding Cell Renovation Project

WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the Budget for Cecil County was approved for Fiscal Year 2019; and WHEREAS, the County Executive is revising the Fiscal Year 2019 Facilities Management Capital Budget to add bond revenue and expense for Cecil County, Maryland; and WHEREAS, such appropriation of unencumbered bond revenue and expense totaling \$50,000 is requested to be added to the Courthouse Holding Cell Renovation Project: a) The project budget for the holding cell project anticipated uncovering asbestos and lead paint during renovations, however, not to the degree uncovered once construction was well underway. The project scope of work was expanded to remediate exposure of both adverse site conditions within the project limits; and NOW THEREFORE, BE IT HEREBY ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for Fiscal Year 2019 is hereby amended for the supplemental appropriation and by amending the Budget to appropriate additional bond appropriation authority within the Facilities Management Capital Projects Budget in the amount of \$50,000 to complete the Courthouse Holding Cell Renovation Project. AND, BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that
