## Supplemental Appropriation – Fund Balance – Voluntary Fire Service – Vehicle Replacement Program

1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and,
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the
6	Budget for Cecil County was adopted for Fiscal Year 2019; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2019 revenue estimate for Cecil
8	County to increase use of the Assigned Fund Balance for Volunteer Fire Company Vehicle Replacement
9	by \$450,000 to allow the following appropriation within the General Fund:
10	a.) The addition of \$450,000 in expenditures for the Volunteer Fire Service Vehicle
11	Replacement Program. The FY2019 Approved Budget for the replacement program was
12	funded in the amount of \$311,975. There were additional equipment replacement requests
13	submitted for FY2019 that were not funded, but in need of replacement. (Chesapeake City
14	VFC – ambulance \$125,000 and Water Witch VFC-engine \$325,000) The County Executive
15	decided to assign fund balance when the FY2018 financials were completed and funds were
16	available to fully fund the FY2019 request; and
17	WHEREAS, such appropriation is necessary to provide \$450,000 of the County Executive's
18	FY2018 assigned fund balance for the General Fund for expenditures.
19	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
20	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
21	Year 2019 is hereby amended for the supplemental appropriation and by amending the Current Budget
22	to appropriate \$450,000 of additional expenditures in the General Fund to the Volunteer Fire Service
23	Department's budget.
24	AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that
25	this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
26	Maryland.
