Supplemental Appropriation – Grant Funds – Solid Waste Enterprise Fund – Agricultural Tire Recycling

1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the
6	Budget for Cecil County was adopted for Fiscal Year 2019; and
7	WHEREAS, the County Executive is revising the Fiscal Year 2019 Solid Waste Enterprise Fund
8	revenue estimate for Cecil County to establish the following amount:
9	a.) The addition of \$179,500 in grant revenue and expense to the Solid Waste Enterprise Fund
10	operating budget to provide for the 2019 Agricultural Tire Collection Event at the Cecil
11	County Central Landfill; and
12	WHEREAS, such appropriation is necessary to provide \$179,500 of grant funding to offset the
13	costs associated with labor, transportation and recycling of agricultural tires. The Maryland
14	Environmental Service (MES) considers any tire (bicycle, ATV, tractor, rubber tracks, earth moving tires,
15	etc.) to be an agricultural tire if they came from a farm. There is no limit on trips from a farm or farmer
16	and no limit on the number of tires from a farm or farmer.
17	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
18	MARYLAND, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
19	Year 2019 is hereby amended for the supplemental appropriation, and by amending the Current Budget
20	to appropriate additional expenditures in the Solid Waste Enterprise Fund to record the grant award in
21	the amount of \$179,500 from Maryland Environmental Service for the purpose of supporting and
22	promoting the recycling of agricultural tires.
23	AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that
24	this Resolution shall take effect on the date of its passage.
