1           **WHEREAS**, pursuant to Section 39.2 (C) of the Code of Cecil County, the County enacted the Cecil  
2 County Public Ethics Laws to guard against improper influence and to require County elected officials,  
3 officials, employees, and individuals appointed to boards and commissions to disclose their financial affairs  
4 and to set minimum standards for the conduct of local government business; and

5           **WHEREAS**, pursuant to Section 39.4(A) of the Code of Cecil County, the Cecil County Ethics  
6 Commission shall be composed of five members with staggered four-year terms; and

7           **WHEREAS**, pursuant to Section 39.4(C) of the Code of Cecil County, no more than three members of  
8 the Commission shall be affiliated with the same political party; and

9           **WHEREAS**, the Ethics Commission is currently comprised of one member who are affiliated with the  
10 Republican Party, three members who are affiliated with the Democratic Party; and

11           **WHEREAS**, pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall appoint all  
12 members of boards and commissions and that such membership shall be subject to confirmation by the  
13 Council; and

14           **WHEREAS**, the County Executive has recommended Bradley Moore for appointment, who is  
15 registered Republican, filling a vacancy, to the Cecil County Ethics Commission, to a four-year term, which is  
16 to expire December 19, 2023.

17           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
18 **MARYLAND**, confirms the recommendation by the County Executive of Bradley Moore for appointment to  
19 the Cecil County Ethics Commission, who is registered Republican, filling a vacancy, to a four-year term to  
20 expire December 19, 2023.

21           **BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all  
22 provisions of the Resolution shall take effect on the date that it is approved.
