1           **WHEREAS**, pursuant to Section 8-201 of the Land Use Article of the Annotated Code of Maryland, a  
2 local jurisdiction may create a historic district commission or a historic preservation commission, and

3           **WHEREAS**, pursuant to the Zoning Ordinance of Cecil County, Article XI, Part IV. Historic District,  
4 Section 245, the Cecil County Historic District Commission was established to preserve historic districts,  
5 landmarks, sites, or structures of historical, archeological, or architectural significance, with their  
6 appurtenances and environmental settings, for the public welfare of the residents of Cecil County, and

7           **WHEREAS**, the Cecil County Historic District Commission is composed of seven members who  
8 possess a demonstrated special interest, specific knowledge, or professional or academic training in the  
9 fields of history, architecture, planning, archeology, anthropology, historic conservation, and related fields;  
10 and

11           **WHEREAS**, all members of the Historic District Commission shall be residents of Cecil County; and

12           **WHEREAS**, the County Executive shall appoint members for terms of three years and members are  
13 eligible for reappointment for three years; and

14           **WHEREAS**, the Historic District Commission shall recommend to the County Council, upon receipt of  
15 a nomination by the owner of record of a property, those properties, structures, or sites found to have  
16 historic, archeological, or architectural significance to be designated as historic districts or landmarks, and

17           **WHEREAS**, the Historic District Commission may recommend to the County Council that a historic  
18 district, site or landmark designation be rescinded or amended; and

19           **WHEREAS**, the Historic District Commission shall conduct an ongoing survey to identify historically  
20 and architecturally significant sites, properties, structures and areas that exemplify the cultural, social,  
21 economic, political or architectural history of the nation, state and county; and

22           **WHEREAS**, the Historic District Commission shall keep a register of properties designated,  
23 determine an appropriate system of markers, advise owners of landmarks, assist owners in nomination of  
24 properties to the National Register of Historic Places, and inform and educate the citizens of Cecil County  
25 concerning the historic and architectural heritage of the County; and

26           **WHEREAS**, pursuant to Section 412(b) of the Charter of Cecil County, the County Executive shall  
27 appoint all members of boards and commissions and that such membership shall be subject to  
28 confirmation by the Council; and

29           **WHEREAS**, the County Executive has recommended Macon H. Coleman, IV for appointment and  
30 Heidi M. Coleman for reappointment to the Historic District Commission, to a three-year term, which is to  
31 expire March 1, 2022.

32           **NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY,**  
33 **MARYLAND**, confirms the recommendation by the County Executive of Macon H. Coleman, IV, for  
34 appointment and Heidi M. Coleman for reappointment to the Historic District Commission to a three-year  
35 term, which is to expire on March 1, 2022.

36           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that all  
37 provisions of this Resolution shall take effect on the date that it is approved.
