# COUNTY COUNCIL OF CECIL COUNTY LEGISLATIVE SESSION MINUTES LSD 2018-21 December 18, 2018

#### **CALL TO ORDER**

The meeting of the County Council of Cecil County of December 18, 2018 was called to order by Council President Meffley at 7:00 p.m. and opened with the Pledge of Allegiance.

#### **OPENING PRAYER**

Councilman Miller introduced Pastor Steve Basht from Ebenezer United Methodist Church, who led the opening prayer.

#### **APPROVAL OF AGENDA**

On motion made by Councilman Coutz, seconded by Councilman Miller, the Council moved to approve the legislative agenda of December 18, 2018. Motion was carried by a vote of 4 to 0. Councilwoman Gregory was absent.

# **APPROVAL OF MINUTES**

# **PUBLIC COMMENTS**

## PRESIDENT AND COUNCIL COMMENTS

Councilman Patchell stated that he had made his comments at the work session.

Councilman Miller commented that he will be attending a meeting at the School of Technology about the new diesel mechanics classes.

Councilman Coutz attended the Shop With A Cop program, which was very successful in matching 104 children with 95 law enforcement officers. The children shopped for gifts and clothing. He stated that he visited the State's Attorney's Office and commented on his concerns for the cramped office space.

Council President Meffley commented on the State's Attorney's Office visit and voiced his concern that each attorney has at least four cases at one time. He also stated that Wicomico County's State's Attorney's Office has thirteen more attorneys than Cecil County with the same population size.

Bill No. 2018-21 Electrical Code – Compliance Requirements – Board of Electrical Examiners

A Bill to amend certain provisions of the Cecil County Code, Chapter 191, Electrical Standards, Article I (General Provisions), Section 191-3 (Compliance With National Electric Code Required), and Article II (Board of Electrical Examiners), Section 191-6 (Membership; Terms, Vacancies).

Bill Funk, Division Chief of Permits and Inspections, provided introductory comments about this legislation. There were no Council questions or comments.

## Resolution No. 44-2018 Water and Sewer – Sewer Use – Connection Charge

A Resolution to re-establish a reduction of the connection fee for residential living units from \$12,000 per equivalent living unit to \$6,000 per equivalent living unit within the Cecil County Sanitary District; to establish that the \$6,000 reduction applies to all subdivisions receiving approval prior to July 31, 2020, and will remain in effect as long as the subdivision maintains its validity; and to re-establish that terms of any installment payment of the wastewater connection charge to be subject to terms as specified in the Sanitary District Policy.

# Resolution No. 45-2018 Budget Amendment – Grant Funds – Courthouse Facilities Maintenance Department - Courthouse LED Lighting

A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland, for the fiscal year ending June 30, 2019, in order to provide a total of \$75,170 to the Special Revenue Other Grants Fund-Courthouse Facilities Maintenance Department to record the incentive awarded from Delmarva Power for the purpose of retrofitting the Cecil County Courthouse with LED lighting.
