**RESOLUTION NO. 18-2019**  
**Budget Transfer and Appropriation – Road Maintenance – Snow Removal**

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the  
6 Budget for Cecil County was adopted for Fiscal Year 2019; and

7           **WHEREAS**, the County Executive is revising the Fiscal year 2019 revenue estimate for Cecil  
8 County and to allocate \$400,000 from the Budget Stabilization Reserve Fund to allow the following  
9 appropriation within the General Fund:

- 10           a.) The addition of \$400,000 (\$350,000 snow removal, \$25,000 overtime, \$25,000 Motor  
11           Vehicle) in expenditures for the Road’s Maintenance snow removal budget to protect  
12           County citizens traveling County maintained roads or repair weather related damage to  
13           roads; and

14           **WHEREAS**, such appropriation is necessary to provide \$400,000 of fund balance from the  
15 Budget Stabilization Reserve Fund for expenditures; and,

16           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
17 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal  
18 Year 2019 is hereby amended for the supplemental appropriation and by amending the Current Budget  
19 to appropriate \$400,000 of additional expenditures in the General Fund to the Road’s Maintenance  
20 Department’s budget.

21           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage  
22 by the County Council of Cecil County, Maryland
