**2020 Cecil County Strategic Plan**

1           **WHEREAS**, pursuant to the Charter of Cecil County, Section 601. Strategic Plan, (a) under the  
2 direction of the Executive, the Government shall establish a strategic plan for the County, which shall  
3 be designed to align the County with anticipated shifts in demographic, economic, legal, political, social  
4 or physical conditions; and

5           **WHEREAS**, the planning horizon shall be at least for five (5) years; and,

6           **WHEREAS**, the first Strategic Plan was adopted in 2014 with a planning horizon of five (5) years;  
7 and

8           **WHEREAS**, the County Executive finds that the Strategic Goals and Objectives of the Strategic  
9 Plan are still relevant and valid; and

10           **WHEREAS**, certain changes have been proposed that include increasing the planning horizon to  
11 ten years to coincide with the next update of the Cecil County Comprehensive Plan, updates to specific  
12 statistics and information throughout, and adding remarks from the County Executive.

13           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
14 **MARYLAND**, that the revised Strategic Plan is in conformance with Section 601 of the Charter of Cecil  
15 County.

16           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**  
17 that the planning horizon set forth pursuant to the Cecil County 2020 Strategic Plan is ten (10) years.

18           **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage  
19 by the County Council of Cecil County, Maryland.
