**RESOLUTION NO. 27-2019**  
**Adoption of Property Tax Rate – FY 2020**

1           **WHEREAS**, Section 6-302 of the Tax-property Article, Annotated Code of Maryland requires the  
2 governing body of each county to annually set the tax rate for the next taxable year; and

3           **WHEREAS**, Section 508 of the Charter of Cecil County requires that County Council shall levy the  
4 amount of taxes required by the Budget to ensure that the Budget is balanced so that proposed  
5 revenues equal proposed expenditures.

6           **NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**  
7 as follows:

- 8           1.     That a County property tax for the taxable year beginning July 1, 2019 and ending June  
9 30, 2020 is hereby levied and imposed on all assessments, persons or property subject to ordinary  
10 taxation in Cecil County;
- 11           2.     That the rate of County taxation for such taxable year for real property is hereby fixed at One  
12 and Four Hundred Fourteen Thousandths Cents (\$1.0414) on each \$100 of assessed valuation of such property;
- 13           3.     That the rate of County taxation for such taxable year for personal property, as well as  
14 for operating real property (as described in Section 8-109(c) of the Tax Property Article, Annotated  
15 Code of Maryland is hereby fixed at 2.6035, which is 2.5000 times the rate as set forth above for real  
16 property; and
- 17           4.     That the Winding Brook Special Taxing District property tax for the taxable year  
18 beginning July 1, 2019 and ending June 30, 2020, is hereby levied and imposed on all parcels in the  
19 Special Taxing District at the rate of 282.12 per parcel.

20           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that  
21 the County Executive and Director of Finance will cause the property tax to be collected in the manner  
22 provided by law.

23           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that  
24 the property tax rates shall be effective July 1, 2019 and shall continue in effect until changed under  
25 the laws of the State of Maryland and/or Cecil County.

26           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that  
27 this Resolution shall take effect on July 1, 2019.
