# COUNTY COUNCIL OF CECIL COUNTY WORK SESSION MINUTES March 26, 2019

# **Economic and Community Value of Cecil County Public Schools**

Dr. Sarah Guy, Assistant Director of Business Economic and Community Outreach Network at Salisbury University, made a presentation regarding the economic and community values of Cecil County Public School system. She provided statistics about the impact that school operations have on the economy, the increase of earning income from students who earn high school and college degrees, the impact of more educated population on tax revenue, and the decrease in the cost of government programs because of a more educated population. Her cost model showed the actual amounts of these impacts for Cecil County. Council Members requested that Dr. Guy provide the methodology used to calculate this cost model.

# **National Library Week**

Morgan Miller, Library Director, invited Council Members and the County Executive to participate in activities during National Library Week, April 7-13, 2019. She provided statistics of library usage and the services provided to library patrons.

Mr. Massey provided an update of the current status of state legislation that the Council had taken a position.
