RESOLUTION NO. 12-2019
Approval - Master Water and Sewer Plan 2018

1 **WHEREAS**, each county shall have a Master Water and Sewer Plan, which has been approved by
2 the Department of the Environment, pursuant to Section 9-503 of the Environment Article of the
3 Annotated Code of Maryland; and

4 **WHEREAS**, the Master Water and Sewer Plan must cover at least 10 year period and be adopted
5 by the county governing body; and

6 **WHEREAS**, the Master Water and Sewer Plan must include the county's water supply systems,
7 sewerage systems, solid waste disposal systems solid waste acceptance facilities and the systematic
8 collection and disposal of solid waste, including litter; and

9 **WHEREAS**, each county governing body shall review its county plan at least once every three years
10 in accordance with a schedule set by the Department of the Environment; and

11 **WHEREAS**, each county governing body shall adopt and submit to the Department of the
12 Environment a revision or amendment to its county plan; and

13 **WHEREAS**, before a county governing body adopts any revision or amendment to its county plan
14 or adopts a new county plan, the governing body shall conduct a public hearing on the county plan, give
15 the principal elected officials of each municipal corporation that is affected notice of the county plan at
16 least fourteen days before the hearing, and

17 **WHEREAS**, notice of the time and place of the public hearing, together with a summary of the
18 plan, shall be published in at least one newspaper of general circulation in the county once each week for
19 two successive weeks, with the first publication of notice appearing at least fourteen days before the
20 hearing; and

21 **WHEREAS**, a public hearing was held by the Planning Commission on January 23, 2019; and

22 **WHEREAS**, the Planning Commission has recommended approval of the Cecil County Master
23 Water and Sewer Plan 2018 (Appendix 1); and

24 **WHEREAS**, the County planning agency has certified that the plan is consistent with the County's
25 Comprehensive Plan and

26 **WHEREAS**, a public hearing by the County Council is scheduled on March 5, 2019; and

27 **WHEREAS**, all requirements of the Environment Article of the Annotated Code of Maryland have
28 been met with regard to the amendment of the Cecil County Master Water and Sewer Plan.

29 **NOW, THEREFORE, BE IT ENACTED, BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,**
30 that the Master Water and Sewer Plan 2018 (Appendix 1) is hereby adopted.

31 **AND, BE IT FURTHER ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND, that**
32 this resolution will become effective on the date of its passage.
