**RESOLUTION NO. 24-2019**  
**Approval – Tasers with Accessories – Multiple Year Contract**

1           **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the  
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and

3           **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held  
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and

5           **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the  
6 County Council adopted the budget for Fiscal Year 2019; and

7           **WHEREAS**, the Cecil County Sheriff’s Office budget for Fiscal Year 2019 includes \$30,000 for  
8 equipment including, but not limited to, tasers; and

9           **WHEREAS**, the Cecil County Sheriff’s Office, by and through Cecil County Government, now  
10 desires to enter into a five (5) year contract with Axon Enterprise, Inc. for the acquisition of Eighty-One  
11 (81) X2 Basic Tasers with tactical battery pack, pinky extender, right-hand holster, 25-foot smart  
12 cartridge, and kit, dataport download and USB, together with two spare tasers; and

13           **WHEREAS**, such acquisition is in excess of \$20,000 and is for multiple fiscal years and, as such,  
14 requires County Council approval in accordance with Section 515(d) of the Cecil County Charter; and

15           **WHEREAS**, the County Executive now seeks County Council approval of the aforementioned five  
16 (5) year contract with Axon Enterprise, Inc.

17           **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**  
18 **MARYLAND**, that the County Executive is authorized to enter into a five (5) year contract with Axon  
19 Enterprise, Inc. for the acquisition of Eighty One (81) X2 Basic Tasers with tactical battery pack, pinky  
20 extender, right-hand holster, 25-foot smart cartridge, and kit, dataport download and USB, together  
21 with two spare tasers.

22           **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that  
23 this Resolution shall take effect on the date of its passage.
