He stated that the increase in fatalities is a result of the introduction of Benadryl into Fentanyl and other Opioids, which prevents Narcan from reviving the drug user.

Vice President Gregory expressed her condolences for the passing of Mary Rodgers, who had been a personal friend and community activist. She said that she would be greatly missed.

Council President Meffley attended Daffodil Days, sponsored by the Cecilton and Galena Lions Clubs. He said that he joined in picking daffodils and delivering them to the community.
