Approval – Gasoline and Diesel Fuel – Multiple Year Contract

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the
6 County Council adopted the budget for Fiscal Year 2019; and

7 **WHEREAS**, the County has a contract for gasoline and diesel fuel that expires on June 30, 2019;
8 and

9 **WHEREAS**, Baltimore County Government, Baltimore County Public Schools, Baltimore County
10 Volunteer Fire Departments, Baltimore County Revenue Authority, Harford County Government, and
11 Harford County Public Schools issued RFP B-1316 and made an award under a cooperative purchasing
12 agreement for the acquisition of gasoline and diesel fuel from PAPCO, Inc.; and

13 **WHEREAS**, the County Executive, on recommendation of the Department of Finance and the
14 Purchasing Office, now desires to enter into a three (3) year agreement with three (3) one-year
15 renewals for gasoline and diesel fuel with PAPCO, Inc., with the contract being a “piggy-back” on the
16 aforementioned Baltimore County Government cooperative purchase RFP B-1316 and award; and

17 **WHEREAS**, such acquisition is in excess of \$20,000 and is for multiple fiscal years and, as such,
18 requires County Council approval in accordance with Section 515(d) of the Cecil County Charter; and

19 **WHEREAS**, the County Executive and Cecil County Sheriff now seek County Council approval of
20 the aforementioned three (3) year contract with three (3) one-year renewals with PAPCO, Inc.

21 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
22 **MARYLAND**, that the County Executive is authorized to enter into a three (3) year agreement with
23 three (3) one-year renewals for gasoline and diesel fuel with PAPCO, Inc., with the contract being a
24 “piggy-back” on the aforementioned Baltimore County Government cooperative purchase RFP B-1316
25 and award to PAPCO, Inc.

26 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
27 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
28 Maryland.
