Road Abandonment – Portion of Nazarene Camp Road, Cecil County

1 **WHEREAS**, Nazarene Camp Road from South Leslie Road to Maryland Route 272, is shown on
2 the maps attached hereto, binds on and is adjacent to a parcel of land owned by Rhine Properties LLC,
3 which is identified as Parcel 0453, Grid 0021 and Map 0025; and

4 **WHEREAS**, the County Executive now seeks abandonment of a section of Nazarene Camp Road
5 from South Leslie Road to Maryland Route 272; and

6 **WHEREAS**, this section of Nazarene Camp Road will be abandoned after said closure and be
7 replaced with a cul-de-sac immediately east of South Leslie Road, and

8 **WHEREAS**, the closure will be effective on April 15, 2019; and

9 **WHEREAS**, the County Council has the authority, pursuant to Local Government Article, Section
10 12-504 of the Annotated Code of Maryland, to open, alter, or close any public road or roads in Cecil
11 County, Maryland; and

12 **WHEREAS**, the County Executive and County Council find that Nazarene Camp Road from South
13 Leslie Road to Maryland Route 272, is no longer needed for public use; and

14 **WHEREAS**, the County Executive and County Council believe that it is in the best interest of the
15 County to abandon Nazarene Camp Road from South Leslie Road to Maryland Route 272, as depicted
16 on the maps; and

17 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
18 **MARYLAND**, approves of the abandonment of Nazarene Camp Road from South Leslie Road to
19 Maryland Route 272.

20 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage
21 by the County Council of Cecil County, Maryland.

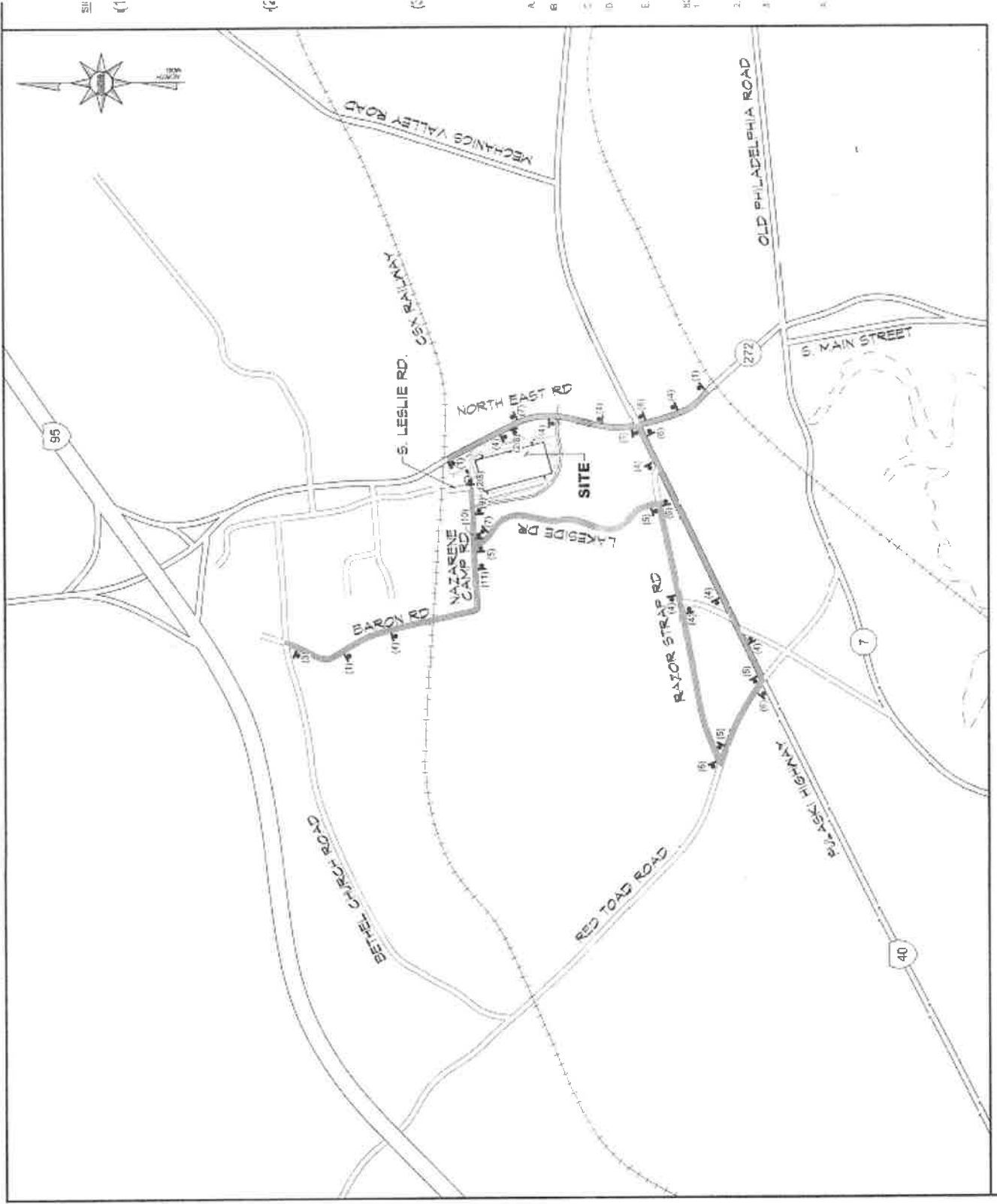
