Budget Appropriation – Grant Funds – Broadband Expansion- Upper Shore Regional Council

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and,

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the
6 Budget for Cecil County was adopted for Fiscal Year 2019; and

7 **WHEREAS**, the County Executive is revising the Fiscal Year 2019 Special Revenue Other Grants
8 Fund revenue estimate for Cecil County to establish the following amount:

- 9 a.) The addition of \$48,400 in revenue and expense to the Special Revenue Other Grants Fund-
- 10 Department of Planning and Zoning operating budget to fund the broadband expansion
- 11 pilot project that aims to provide broadband service to underserved areas in Cecil County.


12 **WHEREAS**, such appropriation is necessary to provide \$48,400 in expenditure authority to allow
13 Cecil County to extend broadband service lines utilizing the customer contribution funding model, to
14 serve approximately 23 homes located on Cat Swamp Road and Barksdale Road in Elkton, MD.

15 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
16 **MARYLAND**, that the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for Fiscal
17 Year 2019 is hereby amended for the supplemental appropriation, and by amending the Current
18 Budget to provide a total of \$48,400 to the Special Revenue Other Grants Fund Department of Planning
19 and Zoning to record the Memorandum of Understanding between the County and Upper Shore
20 Regional Council for the purpose of funding the broadband expansion pilot project in Cecil County.

21 **AND BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage
22 by the County Council of Cecil County, Maryland.
