Title of Resolution: Approval – Internet Service – Windstream – Multiple Year Contract

Synopsis: A Resolution to approve a five (5) year agreement between the County and Windstream Enterprise for the provision of internet services for a maximum period of five (5) years at the monthly rate of \$623.92; pursuant to which Windstream will provide a onetime credit of \$4,600.00 to offset a portion of the cost associated with the installation of a 4” conduit to run cable into the Stemmers Run Department of Public Works office.

1 **WHEREAS**, in accordance with Section 505 of the Cecil County Charter, on April 1, 2018, the
2 County Executive submitted a proposed budget to the County Council for Fiscal Year 2019; and

3 **WHEREAS**, in accordance with Section 506 of the Cecil County Charter, the County Council held
4 public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2019; and,

5 **WHEREAS**, in accordance with Section 507(b) of the Cecil County Charter, on June 5, 2018, the
6 County Council adopted the budget for Fiscal Year 2019; and

7 **WHEREAS**, the Cecil County Department of Information Technology budget for Fiscal Year 2019
8 includes funding to provide internet services to various County offices, including, but not limited, to the
9 Stemmers Run office of the Department of Public Works, located at 45 Stemmers Run Road, Earleville,
10 Maryland; and

11 **WHEREAS**, Windstream Enterprise has agreed to provide a onetime credit of \$4,600.00 to offset
12 a portion of the cost associated with the installation of a 4” conduit to run cable into the Stemmers Run
13 Department of Public Works office, in consideration of the County entering into a five (5) year contract
14 for the provision of internet services at the monthly rate of \$623.92; and

15 **WHEREAS**, the proposed internet services agreement is in excess of \$20,000.00 aggregate, and
16 is for multiple fiscal years, for which County Council approval is required in accordance with Section
17 515(d) of the Cecil County Charter; and

18 **WHEREAS**, the County Executive now seeks County Council approval of the aforementioned five
19 (5) year internet services agreement with Windstream.

20 **NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
21 **MARYLAND**, that the County Executive is authorized to enter into a five (5) year contract with
22 Windstream in the monthly amount of \$623.92 (or less) to provide internet services to the Stemmers
23 Run office of the Cecil County Department of Public Works, located at 45 Stemmers Run Road,
24 Earleville, Maryland.

25 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
26 this Resolution shall take effect on the date of its passage by the County Council of Cecil County,
27 Maryland.
