1 **WHEREAS**, Cecil County has purchased and is in the process of installing and importing data
2 into a new version of a permitting database; and

3 **WHEREAS**, Section 157-4 (Fees) of the Cecil County Code provides that all fees shall be
4 Established by resolution by the Cecil County Council as provided for by law. Copies of the fee schedule
5 will be available in the Department of Permits and Inspections; and

6 **WHEREAS**, the County Executive now requests that the County Council establish a Ten Dollar
7 (\$10.00) Technology Fee as part of the fee schedule for structural building permits to defray the cost of
8 updating and maintaining permitting technology.

9 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
10 **MARYLAND**, that a Ten Dollar (\$10.00) Technology Fee is established.

11 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
12 the Ten Dollar (\$10.00) Technology Fee is established as a part of the fee schedule for structural
13 building permits.

14 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**,
15 that the Technology Fee will be used to offset the cost of obtaining, installing, and maintaining
16 permitting technology.

17 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
18 the Technology Fee shall be effective July 1, 2019 and shall continue in effect until changed under
19 Section 157-4 of the Cecil County Code.

20 **AND BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND**, that
21 this Resolution shall take effect on July 1, 2019.
