WHEREAS, Cecil County, Maryland provides length of service awards ("VLOSAP Benefits") to
qualified members of Cecil County volunteer fire departments, ambulance corps and rescue
squads pursuant to the Cecil County Volunteer Length of Service Award Program Bylaws (as
amended, the "Program");
WHEREAS, pursuant to Section 17-102 of the Local Government Article of the Annotated
Code of Maryland, the trustees in charge of a trust fund account of a political subdivision may
invest and reinvest monies under their custody or control as provided by the laws enacted by the
governing body of the political subdivision; and
WHEREAS, Cecil County, Maryland wishes to authorize the establishment of a trust fund
for the Program and to authorize the trustees of the trust fund to invest and manage the assets of
the trust fund as provided herein.
NOW THEREFORE, BE IT HEREBY ENACTED BY THE COUNTY COUNCIL OF CECIL COUNTY,
MARYLAND, as follows:
Section 1. Cecil County, Maryland (the "County") hereby authorizes the establishment of
the "Cecil County, Maryland Volunteer Length of Service Award Program Trust Fund" (the "Trust
Fund"), under the terms and conditions set forth in a trust agreement to be entered into by the
County and the trustees of the fund, substantially in the form of the Cecil County, Maryland
Volunteer Length of Service Award Program Trust Agreement attached hereto as Appendix 1 (the
"Trust Agreement").
Section 2. The Trust Agreement and the provisions therein regarding the administration of
the Trust Fund are hereby approved.
Section 3. The purpose of the Trust Fund is to assist the County in financing benefits
provided by the County under the Program from time to time.
Section 4. The Trustees shall have full power and authority to invest and manage the
assets of the Trust Fund in accordance with the Trust Agreement.
Section 5. The Trustees hereunder shall consist of (1) the Director of Finance of the
County, or his or her designee, (2) the Budget Manager, or his or her designee, (3) the Director of
Human Resources, or his or her designee, (4) the Director of Emergency Services, or his or her
designee, (5) the President of the Cecil County Firemen's Association, or his or her designee, and

(6) a current member of the Cecil County Council as appointed by the Council as a non-voting member.

Section 6. Neither the establishment of the Trust Fund nor the establishment or maintenance of a reserve to pay VLOSAP Benefits under the Program shall be construed as creating or evidencing an obligation on the County's part to maintain or continue its practice of providing VLOSAP Benefits; rather, the County expressly reserves the right to alter, amend, modify, or terminate its practice of providing VLOSAP Benefits under the Program.

Section 7. As set forth in Section 7.02 of the Trust Agreement, the Trust Agreement may be amended by executive order of the County Executive, after such amendment is approved by 2/3 vote of the Trustees and approved by Bill by the County Council.

<u>Section 8</u>. This Act, being necessary for the welfare of the inhabitants of Cecil County, shall be liberally construed to affect its purposes.

Section 9. The provisions of this Act are severable, and if any provision, sentence, clause, section or part hereof is held to be illegal, invalid or unconstitutional or inapplicable to any person or circumstances, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Act or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this Act would have been passed if such illegal, invalid or unconstitutional provision, sentence, clause, section or part had not been included herein, and if the person or circumstances to which this Act or any part hereof are inapplicable had been specifically exempted therefrom.

AND BE IT FURTHER ENACTED that this Act shall take effect 60 calendar days from the date it becomes law.
