Creation and Appointment – Compensation Review Commission

WHEREAS, in accordance with Section 207 of the Charter of Cecil County, the County Council is
required to establish a Compensation Review Commission every four years to review the Council's
compensation and allowances, and in accordance with the provisions of the Local Government Article,
Section 10-302 of the Annotated Code of Maryland ; and
WHEREAS, the County Council shall have the authority to increase the compensation and
allowances for Council Members by the affirmative vote of the majority of Council Members; and
WHEREAS, the compensation and allowances to Council Members shall not be increased or
reduced during his or her current term; and
WHEREAS, in accordance with Section 406 of the Charter of Cecil County, the County Council is
required to review the Executive's compensation and allowances, and make a recommendation to the
Council, and
WHEREAS, the County Council shall have the authority to increase the compensation and
allowances for the Executive by the affirmative vote of the majority of Council Members; and
WHEREAS, the County Council shall also have the power to reduce the Executive's
compensation and allowances by the affirmative vote of not less than two-thirds of the Council
Members; and
WHEREAS, the Executive's compensation cannot be reduced by a figure lower than that
provided in the Charter except by amendment; and
WHEREAS, the compensation and allowances to the Executive shall not be increased or reduced
during his or her current term; and
NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
MARYLAND, the County Council shall appoint ten members of the Compensation Review Commission
and the Commission will elect a Chair from among Commission members. The Compensation Review
Commission will determine a recommendation for the compensation and allowances of the County
Executive and County Council Members in open meetings. The Compensation Review Commission
shall make a recommendation to the County Council no later than September 3, 2019.
BE IT FURTHER RESOLVED, that the appointments of members to the Compensation Review
Commission will be included in this legislation, by the affirmative vote of the majority of Council
Members.
