DETOUR PLAN

1. THE CONTRACTOR SHALL NOTIFY THE CECIL COUNTY DEPARTMENT OF PUBLIC WORKS 24 HOURS PRIOR TO IMPLEMENTING THIS PLAN.
2. ALL WARNING SIGNS AND DETOUR ROUTE SIGNS SHALL BE PLACED PRIOR TO COMMENCING ANY WORK ON THE PROJECT. THEY SHALL BE COMPLETELY COVERED UNTIL APPLICABLE TO WORK.
3. ALL WORK SHALL BE CONDUCTED IN ACCORDANCE WITH THE LATEST VERSION OF THE MARYLAND STATE HIGHWAY ADMINISTRATION'S (MSHA) BOOK OF STANDARDS FOR HIGHWAY AND INCIDENTAL STRUCTURES AND MSHA'S 2011 MARYLAND MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES (MDMUTCD).
4. ACCESS TO PRIVATE PROPERTY ENTRANCES SHALL BE MAINTAINED AT ALL TIMES.
5. EXISTING ROUTE MARKERS AND ANY OTHER CONFLICTING DIRECTIONAL SIGNS SHALL BE COVERED OR REMOVED, THEN REPLACED WHEN THE DETOUR IS ELIMINATED.
6. AT THE ROADWAY CLOSURE ONLY, INSTALL TYPE III BARRICADES WITH (2) FLASHING TYPE A LOW INTENSITY WARNING LIGHTS. SIGNS ON BARRICADE TO BE PAID FOR SEPARATELY. INSTALL TEMPORARY PRECAST DOUBLE FACE F-SHAPE CONCRETE BARRIER BEHIND TYPE III BARRICADE.
7. INSTALL SIGN M A MINIMUM OF TWO WEEKS PRIOR TO BEGINNING WORK.
8. THE LOCATION OF ALL SIGNS MUST BE APPROVED BY THE ENGINEER PRIOR TO INSTALLATION.
