6	WHEREAS, a county shall develop a multiyear plan for the expenditure of the local impact grant
7	funds for services and improvements, in consultation with the Local Development Council; and
8	WHEREAS, the Local Development Council will review and comment on the multiyear plan before
9	adopting the plan or expending any grant funds; and
10	WHEREAS, the Local Development Council will advise the county on the impact of the facility on
11	the communities and the needs and priorities of the communities in immediate proximity to the facility;

13	WHEREAS, Article 4, Section 412 (b) of the Charter of Cecil County provides that the County
14	Executive shall appoint all members of boards and commissions, subject to confirmation by the Council;
