1 **WHEREAS**, Maryland’s Enterprise Zone Tax Credit Program is a joint effort between the
2 State and local governments to provide tax incentives to businesses and property-owners located
3 in economically distressed communities; and

4 **WHEREAS**, the Cecil County Enterprise Zone was approved by the State of Maryland on
5 June 15, 2013, thus providing an important economic development tool for the County and the towns of
6 Perryville, North East and Elkton; and

7 **WHEREAS**, the Cecil County Office of Economic Development desires to have the current Zone
8 expanded to allow existing businesses in Cecil County and prospective new businesses to utilize these
9 incentives; and

10 **WHEREAS**, the application will include all those twenty (20) properties shown on the attached map,
11 Exhibit A, and the attached parcel listing, Exhibit B, in all totaling 1.786.76 acres, more or less, of which
12 372.23 acres more or less lie within the Town of Elkton; and

13 **WHEREAS**, the primary benefits to businesses that are located within an Enterprise Zone are
14 eligibility for local property tax credits and State income tax credits; and

15 **WHEREAS**, eligible businesses in an enterprise zone may claim a ten-year credit against local real
16 property taxes on a portion of real property improvements. The credit is 80 percent of the assessment
17 increase during the first five years. The credit then decreases 10 percent annually thereafter to 30 percent
18 in the tenth year; and

19 **WHEREAS**, eligible businesses in an enterprise zone may claim one-year or three-year credits for
20 wages paid to new employees in new positions. The general credit is a one-time \$1,000 credit
21 per new worker. For economically disadvantaged employees, the credit increases to a total of
22 \$6,000 per worker distributed over three years. Businesses claim the enterprise zone income tax
23 credits on the 500CR form when they submit their business or individual income tax returns to
24 the Comptroller; and

25 **WHEREAS**, the Enterprise Zone is an important incentive for the County to encourage existing
26 businesses to expand and in attracting new businesses to locate within Cecil County; and

27 **WHEREAS**, the application for the subject Enterprise Zone must be filed with the State of Maryland
28 Department of Commerce on or before October 15, 2019.

29 **NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,**
30 **MARYLAND,** that this application to expand the Cecil County Enterprise Zone to include twenty (20) parcels
31 totaling 1,788± acres as reflected in Exhibits A and B attached hereto, is approved.

32 **AND, BE IT FURTHER RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY, MARYLAND,** that this
33 Resolution is hereby declared to be an expedited measure and necessary for a situation that was
34 unanticipated, urgent, a pressing and compelling need requiring immediate action in order to submit the
35 enterprise application to the Maryland Department of Commerce on or before October 15, 2019.

36 **AND, BE IT FURTHER RESOLVED** that this Resolution shall take effect on the date of its passage by
37 the County Council of Cecil County, Maryland.
