1	WHEREAS, in accordance with Section 505 of the Cecil County Charter, on April 1, 2019, the
2	County Executive submitted a proposed budget to the County Council for Fiscal Year 2020; and
3	WHEREAS, in accordance with Section 506 of the Cecil County Charter, the County Council held
4	public hearings on the proposed budget submitted by the County Executive for Fiscal Year 2020; and
5	WHEREAS, in accordance with Section 507(b) of the Cecil County Charter, on June 4, 2019, the
6	County Council adopted the budget for Fiscal Year 2020; and
7	WHEREAS, the State of Maryland through the Department of Housing and Community
8	Development has solicited applications from eligible jurisdictions to apply for funding under the
9	Maryland Community Development Block Grant Homeless Initiative Program; and
10	WHEREAS, Cecil County is eligible to apply for funds from the Maryland Community
11	Development Block Grant Homeless Initiative program through the Maryland Department of Housing
12	and Community Development; and
13	WHEREAS, the Department of Community Services, representing Cecil County, has been
14	authorized to apply for grant funds designated for Homeless projects in Cecil County; and
15	WHEREAS, the Department of Community Services, through its Housing and Community
16	Development Division and in collaboration with community partners, recognizes that funding must
17	be used for projects benefitting homeless persons to include acquisition, construction or
18	renovation of housing units for transitional or rapid re-housing; construction or renovation of
19	shelters; and operating costs where a quantifiable increase in the level of services can be
20	demonstrated; and
21	WHEREAS, the County has held the required public hearing related to the formulation of the
22	County's Block Grant Application; and
23	WHEREAS, the County Council understands and acknowledges that the County would be
24	responsible for completion of grant activities and any corrective actions including the repayment of
25	funds if necessary.
26	NOW THEREFORE, BE IT HEREBY RESOLVED BY THE COUNTY COUNCIL OF CECIL COUNTY,
27	MARYLAND, that the County Executive, by and through the Cecil County Department of Community
28	Services, is authorized to submit an application for Community Development Block Grant Homeless
29	Initiative funds.
