Appointment - Board of Library Trustees - Jonathan Stauffer

WHEREAS, pursuant to Section 23-401 of the Education Article of the Annotated Code of 1 Maryland, the county governing body may establish a county public library system free from political 2 influence: and 3 WHEREAS, each county public library system shall be governed by a board of trustees; and 4 WHEREAS, pursuant to Section 23-403 of the Education Article of the Annotated Code of 5 6 Maryland, each board of library trustees consists of seven members appointed by the county governing body from nominees submitted by the board of library trustees; and 7 WHEREAS, pursuant to Section 23-405 of the Education Article of the Annotated Code of 8 Maryland, each board of library trustees has the powers and duties to establish and operate the library, 9 determine library policies, adopt rules, regulations and bylaws for the use of the library, approve the 10 library budget and spending of public funds, and approve of the annual audit and annual report; and 11 WHEREAS, Section 412 (b) of Article 4 of the Charter of Cecil County provides that the County 12 Executive shall appoint all members of boards and commissions, subject to confirmation by the Council; 13 and 14 WHEREAS, the County Executive has recommended Jonathan Stauffer for appointment to the 15 Cecil County Board of Library Trustees, to a five year term, which is to expire on September 3, 2024. 16 NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE COUNTY COUNCIL OF CECIL COUNTY, 17 MARYLAND, confirms the recommendation by the County Executive of Jonathan Stauffer for 18 appointment to the Cecil County Board of Library Trustees, to a five year term, which is to expire on 19 September 3, 2024. 20 AND, BE IT FURTHER RESOLVED that this Resolution shall take effect on the date of its passage by 21 22 the County Council of Cecil County, Maryland.
