### **INFORMATIONAL ITEMS**

- Friends of CCPR: Thomas McFadden gave an update on the 501c3. Justin Bakeoven stepped down as Chairman, Thomas has moved into that role. The "pop-up play date" to promote the "Friends" at Brantwood Park went well, Sweet Cowalines participated by hiding rocks around the park with free ice cream cone labels. A "movie in the park" is scheduled for Calvert Regional Park in September. The 501c3 is reviewing candidates to add to the board. All current board members have agreed to sit for one more year. Meetings will be held with the Kiwanis Club & the Conowingo Lions Club. The Board is now part of Amazon Smile.
- Project Update: Phase III of Calvert Regional Park is in the plan review process with an anticipated start date
  of April/May 2020. Phase III will be split into sections A/B & will include additional fields, parking, and road
  improvements. Elk River Dredging will be begin this fall. The turf field at North East High School is scheduled
  to be completed prior to the first home game. A masterplan for Brantwood will be developed with input from
  the Parks Board, the Friends, meetings with the public & an online survey.
- Program Update: Wolfpack Football has 150 players register with Cheer having 50. The Movers program in Elementary and Middle Schools has begun. The YEA program is currently being staffed & teachers are providing a list of students who would most benefit from the program. Two Lacrosse tournaments will be held in October and one in November. There are currently three vacancies in the Maintenance Division that we are working to fill. Five fields at Calvert Regional Park were over-seeded with Bermuda seed in July. County High School Field Hockey teams & Cecil College Soccer are using Field 1 and the turf field at Calvert Regional Park.
- Heat Policy: A heat policy for County athletic fields is being considered. The County will review other
  jurisdictions before making a decision & would also need to discuss the policy with the schools.
