The County Council of Cecil County met in legislative session at the County Administration Building, 200 Chesapeake Blvd., Elk Room, Elkton, MD. The following members of the Council were present:

CALL TO ORDER

The meeting of the County Council of Cecil County of September 17, 2019 was called to order by Council President Meffley at 7:00 p.m. and opened with the Pledge of Allegiance.

OPENING PRAYER

APPROVAL OF AGENDA

Resolution No. 51-2019 Supplemental Appropriation – Fund Balance – Volunteer Fire Service

A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2020 in order to provide the Volunteer Fire Service Department Budget within the General Fund additional expenditure appropriation authority in the amount of \$164,154. The additional expenditure authority will fund the FY20 allocation budget shortfall resulting from the error by the Maryland State Assessment Office in the assignment of fire district codes to new County properties. There were no comments from the administration. Councilman Coutz clarified that this application is for a competitive grant award.

A Resolution to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2020 in order to provide a total of \$102,120 to the Community Services Fund — Help Center Division to record the Child and Adult Care Food Program (CACFP). Funding and oversight for the program will be passed from the Department of Social Services to Cecil County as part of the consolidation efforts between the two government agencies.

Bill No. 2019-14 Budget Transfer and Appropriation – Capital Budget – Roads and Bridges Capital Budget – Belvidere Road Culvert Project

A Bill to amend the Annual Budget and Appropriation Ordinance for Cecil County, Maryland for the fiscal year ending June 30, 2020 to transfer existing bond appropriation authority within the Roads & Bridges Capital Projects Budget in the amount of \$128,707.96 from a portion of the savings on the completed Upgrade Nottingham Roads Facility Project (\$18,353.68) and the completed Waibel Road Improvement Project (\$110,354.28); to be transferred to the Replace Belvidere Road Culvert Project (\$128,707.96).

The Bill was introduced on August 6, 2019, and the public hearing was held and concluded on September 3, 2019.

Al Wein, Director of Administration, provided final comments. There were no Council questions or comments.

On motion made by Councilman Coutz, seconded by Vice President Gregory, the Council moved to approve Bill No. 2019-14.

Cecil County Public Schools – Budget Amendment #66

Councilman Coutz made a motion, seconded by Vice President Gregory, to approve Cecil County Public Schools Budget Amendment #66, in the amount of \$4,384,893 for July and August 2019.

The motion was approved by a voice vote of 5 to 0.
