| 15 | seniors as the advisory council to the Area Agency on Aging in Cecil County; and                     |
| 16 | WHEREAS, the Commission on Aging identifies, assesses, and advocates for the needs of the            |
| 17 | growing older adult population in Cecil County; encourages the development of services designed to   |
| 18 | address those needs; and supports the mission of the Senior Services and Community Transit of        |
| 19 | Cecil County of developing and coordinating community-based systems of services for all older        |
| 20 | adults in the County; and  |
| 21 | WHEREAS, Pursuant to Section 412(b) of the Charter of Cecil County, the Executive shall              |
| 22 | appoint all members of boards and commissions and that such membership shall be subject to           |
| 23 | confirmation by the Council; and   |

| 25 | appointment to the Cecil County Commission on Aging, to a three year term, which is to expire on     |
